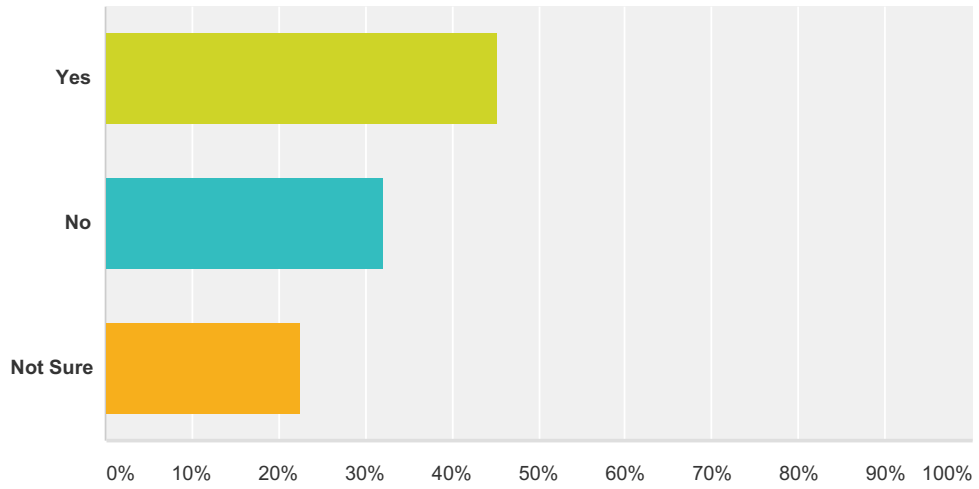


Q1 Do you believe you are eligible to apply for the NPEA under the draft guidelines?

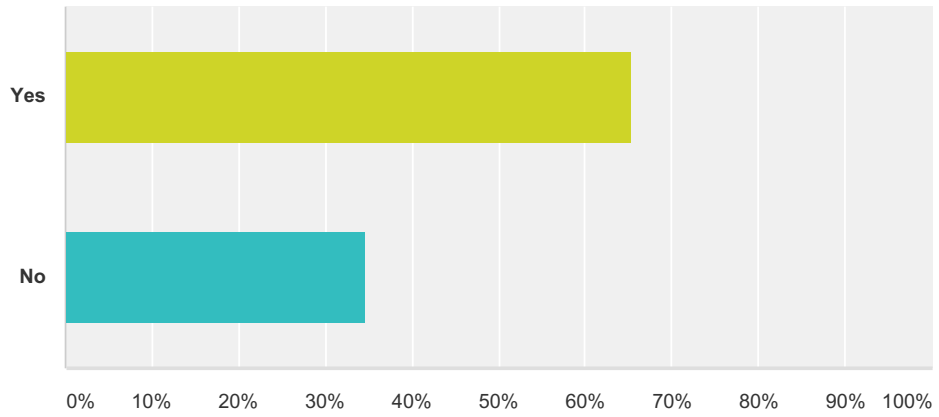

Q2 Would you consider applying to the NPEA under the current guidelines?

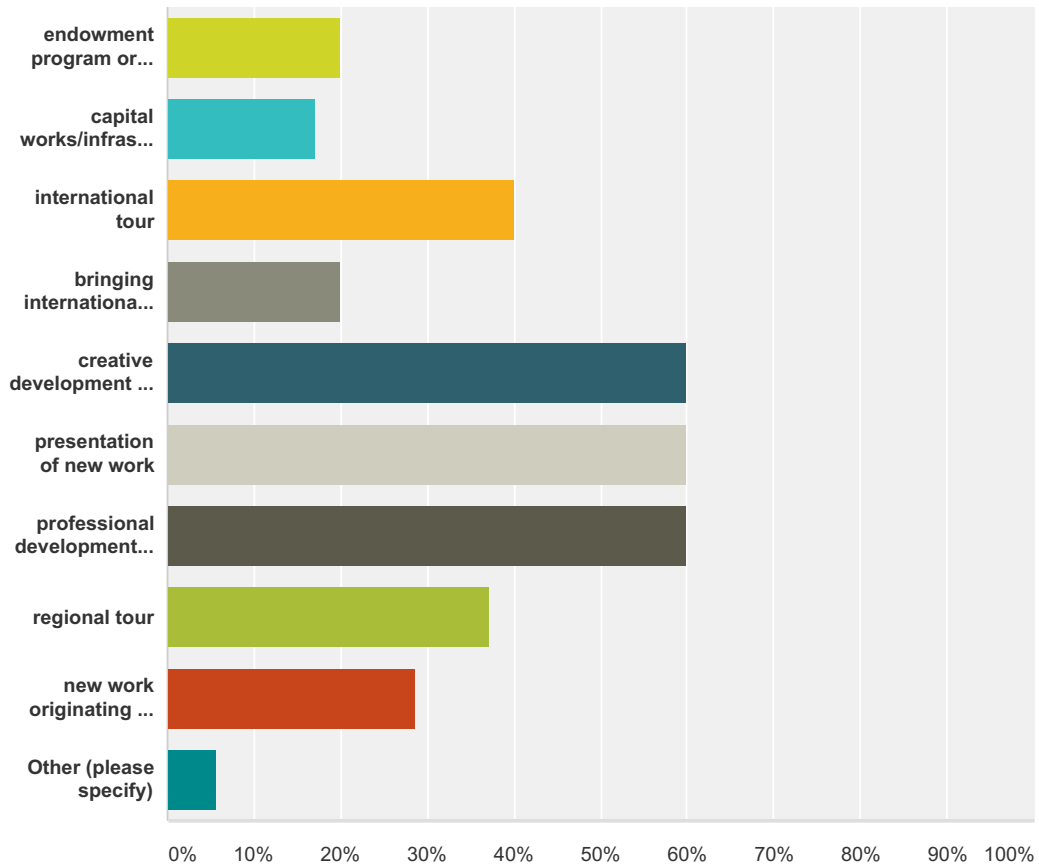

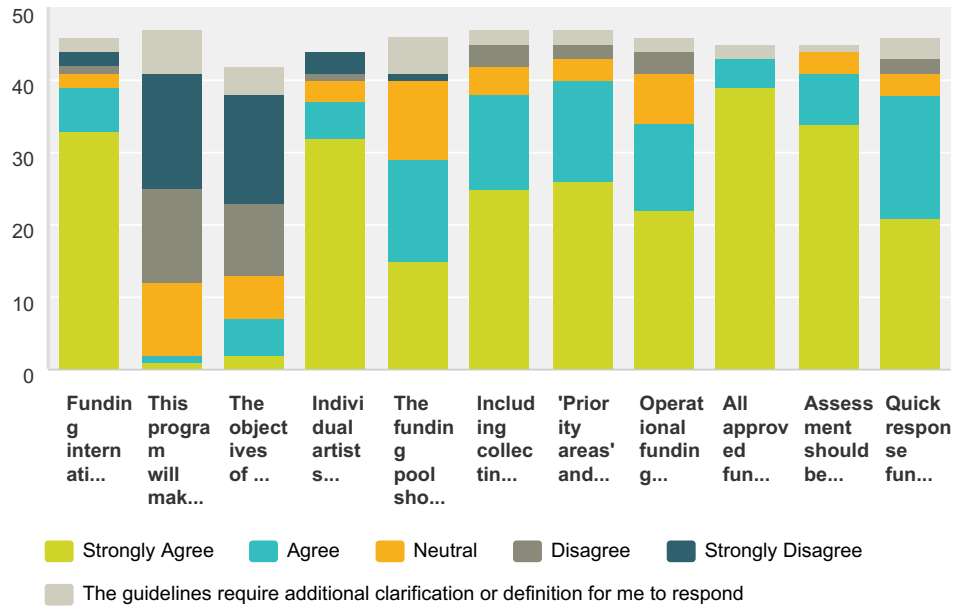
