Backstory: TNN currently relies on state government funding in order to provide programming and services to support the NSW theatre sector. In 2019 TNN received 60% of its annual program funding request for service organisations from NSW Government which means it cannot sustain its normal operations. The agency has been advised that without additional income streams, we are unlikely to receive future funding. We work with the sector, for the sector. It took the sector 10 arduous years to bring Theatre Network NSW into being and create the programs and activities of the last 4 years of the organisation's life.

But what now? Do we close the doors? What becomes of TNN? Does NSW theatre need a network, a peak agency, any longer? What do you want, what do you need, and how can we ensure it is provided? If we can find a way to continue operations beyond 2019, how do we sustain the agency – what does the business model look like?

These questions and more await us at our May Day forum...and we'll have drinks to follow for those who can. Please come along and bring as many of your friends and colleagues with you that you can muster. We only get one shot at this and your voice matters.

Page 17 of TNN 2018 Approved Constitution referencing Clause 32. Quorum for General Meetings

- the secretary, any one or more of the members who made the requisition may convene a special general meeting to be held not later than 3 months after that date.
- (5) A special general meeting convened by a member or members as referred to in subclause (4) must be convened as nearly as is practicable in the same manner as general meetings are convened by the board.

31. Notice

- (1) Except if the nature of the business proposed to be dealt with at a general meeting requires a special resolution of the association, the secretary must, at least 14 days before the date fixed for the holding of the general meeting, give a notice to each member specifying the place, date and time of the meeting and the nature of the business proposed to be transacted at the meeting.
- (2) If the nature of the business proposed to be dealt with at a general meeting requires a special resolution of the association, the secretary must, at least 21 days before the date fixed for the holding of the general meeting, cause notice to be given to each member specifying, in addition to the matter required under subclause (1), the intention to propose the resolution as a special resolution.
- (3) No business other than that specified in the notice convening a general meeting is to be transacted at the meeting except, in the case of an annual general meeting, business which may be transacted under clause 29 (2).
- (4) A member desiring to bring any business before a general meeting may give notice in writing of that business to the secretary who must include that business in the next notice calling a general meeting given after receipt of the notice from the member.

32. Quorum for general meetings

- (1) No item of business is to be transacted at a general meeting unless a quorum of members entitled under this constitution to vote is present during the time the meeting is considering that item.
- (2) Thirty percent (30%) (rounded down to the nearest whole number) of the total number of members entitled under this constitution to vote at a general meeting constitutes a quorum for the transaction of the business of a general meeting.
- (3) If within half an hour after the appointed time for the commencement of a general meeting a quorum is not present the members present, being at least twenty percent (20%) (rounded down to the nearest whole number) of the total number of members entitled under this constitution to vote at a general meeting, are to constitute a quorum.
- (4) If at least twenty percent (20%) (rounded down to the nearest whole number) of members are not present within half an hour after the appointed time as per subclause (3) above, then the general meeting is to be dissolved and adjourned to the same day in the following week at the same time and (unless another place is specified at the time of the adjournment by the person presiding at the meeting or communicated by written notice to members given before the day to which the meeting is adjourned) at the same place.

2018 – A Year in Review

Programming and Events:

TNN produced twice the amount of industry events as planned due to high demand for such events in our sector. These events relate to sector needs, opportunities, concerns.

APAM February 2018

Partnering with Create NSW to maximise engagement, TNN's APAM 2018 booth provided representation of and connection between NSW theatre venues, producers and networks. It is particularly important for independent artists and venues who cannot afford to attend APAM but would benefit from having their work profiled or having TNN develop useful networking connections for them to follow up on. At least 25 companies were officially represented at the booth. Three particular outcomes from TNN's participation at APAM were:

- 1. A NSW Circus Peers Group providing support and advice to those working or emerging into the field of circus in NSW.
- 2. Imagine Better (Theatre and the Environment): Imagine Better Working Group (July 2018) and Draft 1 of the Imagine Better Resource Guide (December 2018) for environmental responsibility in NSW theatre.
- 3. Independent Theatre Event at Artstate Tamworth for 2019 with Critical Stages Touring and RANSW

TNN's HR Best Practices and Defamation Law Workshop 16th May 2018

This event was developed and produced by TNN to be a practical and informative tooling up session for both artists and arts workers, filling in gaps of knowledge that have been highlighted in recent months. Hosted at ATYP, this event is Chaired by Senior Solicitor of the Arts Law Centre of Australia, Suzanne Derry and provides information sessions and discussion with entertainment lawyer Ben Kay (Partner, Kay and Hughes) and HR Director Catherine Cahill (Michael Cassel Group). Over 60 people attended this event.

Young People and The Arts Forum NSW 30th May 2018

Theatre Network NSW (TNN) is partnered with Theatre Network Australia (TNA), Australian Theatre for Young People (ATYP), Polyglot, Create NSW, Sydney Opera House and Currency House to present an industry forum that continues the conversation around Sue Giles' recent Platform Paper, 'Young People and the Arts: An agenda for change'. As part of this partnership, TNN sourced NSW Presenters and provided TNN Travel Subsidies for TNN members travelling from regional NSW (includes Newcastle & Wollongong) to the event.



2018 NSW Theatre Gathering 27th November 2018

The NSW Theatre Gathering 2018 began life in the foyers, rehearsal rooms, and meeting places of the NSW theatre sector in May 2018. Its unique and previously untested process, was developed by Theatre Network NSW's Executive Director Jane Kreis in collaboration with the sector over a 6-month process with final event being held on 27th November and attended by the Minister for the Arts. The aim of the gathering was to allow for strengthened connection and to develop the sector's ability to communicate the inherent value of theatre as an art form. Over 250 people attended this event.



Sector consultation and research on key sector issues or questions.

Again, TNN exceeded its planned consultation and research KPIs with reports including:

- 1. Reflections on APAM 2018...
- 2. What's On Your Mind? Theatre Sector Survey Report identifying key concerns and opportunities in our sector a comparative analysis between 2017 and 2018.
- 3. Wellbeing in the Performing Arts of NSW The next steps for Wellbeing in our Industry
- 4. 'What Next? Women In the Arts' Update in partnership with WITS, September 2018
- 5. NSW State of Theatre Address and Monologues (Draft Report for publication in 2019)

Capacity Building Services: a core part of TNN activity, providing the sector with specific information, support and networking. This includes meetings, phone calls, emails, general advice, referrals and connecting the sector.



TNN fielded over 1000 enquiries from the NSW theatre sector on topics including: Auspicing, funding assistance, wellbeing, business partnerships, policy and programming, youth theatre, promotion, touring, professional developing and training, cultural diversity, support for venues, local government engagement, education and NSW theatre curriculum.



In addition, in 2019 TNN was asked to advocate on the sector's specific concerns relating to federal funding, philanthropy, wellbeing and mental health, state funding, sexual harassment. TNN developed specific advocacy resources on all of those matters.

TNN also uses its sector connectivity to determine key areas for research and development. In 2018 TNN managed a variety of sector-led initiatives and working groups including:

- 1) NSW Theatre Producers Working Group: 2018 outcomes include sector workshops and advocacy for: improvements in workplace culture specifically in relation to bullying, harassment, sector engagement with community around the value of theatre.
- 2) NSW Performing Arts Wellbeing Group: 2018 outcomes include wellbeing and resilience workshops with TAFE NSW and other providers, partnership meetings with business and peer support providers, a scoping document to secure resources for the development of a comprehensive and arts industry-specific Wellbeing plan for NSW.
- 3) Independent Theatre Working Group: 2018 outcomes include Indy theatre sector updates x 2, revision of Equity Ethical Independent Theatre Code of Practice, meetings with City of Sydney and other LGAs about venue development/access, submissions for funding for workshops in Conflict Resolution and Workplace Safety.
- Imagine Better: Theatre and Environment Working Group: 2018 outcomes include Imagine Better Working Group (July 2018), two meetings of the group, and initial draft of an Imagine Better Resource Guide (December 2018) for environmental responsibility in NSW theatre using case studies from NSW.

All of these working groups also presented at the NSW Theatre Gathering 2018.

Communications: TNN also published bi-monthly e-news as well as 6 targeted information and engagement campaigns with key segments of our sector. Invitations to members and stakeholders were sent for each event or activity TNN produced.

Membership Campaign: In response to Create NSW and Panel Feedback, TNN focussed considerable resources and attention on promoting and building membership. It revitalised its membership package and launched its membership campaign in September 2018 with a 200% increase in membership by November of that year. TNN currently has over 160 members and connects regularly with another 800 stakeholders.

Committee's Report

Your committee members submit the financial report of Theatre Network NSW Inc for the financial year ended 31 December 2018.

Principal Activities

In 2018 Theatre Network NSW programmed and delivered a suite of services, events, professional development, and research projects dedicated specifically for the NSW theatre industry with a focus on building capacity in the independent and small to medium sector of this industry. Theatre Network NSW was successful in its application for annual program funding to Create NSW while also adding to its programming budget through workshop fees and Associate membership finishing the year with a small surplus of \$57.21.

Significant Changes

In 2018 Theatre Network NSW (TNN) experienced another challenging year. TNN welcomed several new board members including Imogen Gardam and Nick Atkins while farewelling inaugural members Viv Rosman and Stephen Champion. In September 2018 Theatre Network NSW was granted Deductible Gift Recipient status with the Register of Cultural Organisations. The constitution was amended to provide all members were allocated members rights and the take up of new memberships has been encouraging.

Going Concern

This financial report has been prepared on a going concern basis which contemplates continuity of normal business activities and the realisation of assets and settlement of liabilities in the ordinary course of business. The ability of the association to continue to operate as a going concern is dependent upon the ability of the association to generate sufficient cashflows from operations to meet its liabilities. Notes of the Financial Statements

Theatre Network NSW Inc. For the year ended 31 December 2018

Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act (NSW). The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Employee Provisions

Provision is made for the association's liability for employee benefits arising from services renderedby employees to the end of the reporting period. Employee provisions have been measured at theamounts expected to be paid when the liability is settled.

Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result ofpast events, for which it is probable that an outflow of economic benefits will result and that outflowcan be reliably measured. Provisions are measured at the best estimate of the amounts required to ettle the obligation at the end of the reporting period.

Cash on Hand

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in theassets and liabilities statement.

Financial Assets

Investments in financial assets are initially recognised at cost, which includes transaction costs, and are subsequently measured at fair value, which is equivalent to their market bid price at the end of the reporting period. Movements in fair value are recognised through an equity reserve.

Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.
